

**Animal Geography Specialty Group (AnGSG)
2009-2010 Annual Report**

1) Mission Statement

The Animal Geography Specialty Group strives to enhance geographic research and scholarship on matters relating to human-animal studies by: (a) encouraging the exchange of ideas among geographers studying biological, cultural, ecological, economic, political, and technical aspects of the myriad ways humans co-exist with other animal species, (b) promoting research in these areas, (c) facilitating collaboration between existing AAG specialty groups and committees to promote common interests and develop intra-disciplinary and interdisciplinary projects. The overall aim of AnGSG is to support discussion of human-animal issues by geographers as a legitimate and active part of the discipline.

Business Meeting at the AAG 2010 Conference in Washington DC: We had nine attendees at the meeting. Our main item of business was to amend the bylaws to add an additional graduate student representative. We now have two graduate student representatives serving staggered terms. It was agreed at the meeting that this will help provide continuity and cohesiveness for graduate students interested in animal geography.

Student Paper Awards: Have been finalized for the 2011 meeting. First call was posted to Animal Geography Specialty Group listserv in Oct, 2010, with text as follows:

The Animal Geography Specialty Group (AnGSG) of the AAG invites submissions for its first Graduate Student Paper Award competition. Eligible papers must be presented at the Annual Meeting of the AAG (Seattle, Washington, April 2011) and based on original empirical or theoretical research in the field of Animal Geography; literature reviews will not be considered. Papers submitted to other AAG paper competitions are not eligible. The student must be a member of the AnGSG at the time of submission and the sole author of the paper.

Manuscripts should not exceed 8000 words, and should be accompanied by a cover letter that includes the title of the paper, brief abstract (maximum 250 words), name of the author, academic affiliation, mailing address, email address and phone numbers. Papers will be evaluated by a subcommittee of AnGSG members. One \$250 cash prize will be awarded to the winner, whose name will be announced at the AnGSG business meeting in Seattle. The name of the winner will also be announced in both the AAG and AnGSG newsletters.

Submissions must be received by March 1, 2011. Please send the paper in electronic form (.doc, .docx, or .pdf) to both the AnGSG Chair, Monica Ogra (mogra@gettysburg.edu) and AnGSG Secretary-Treasurer, Julie Urbanik (urbanikj@umkc.edu).
